- (b) Expression of interest addressed to Mission Director, Horticulture Development Society, Patna should be submitted to the State Horticulture Mission, 2nd Floor, Pant Bhawan, Bailey Road, Patna – 800 001 (Bihar).
- (c) The company/firm should submit their offer duly sealed and super scribed on the top of the envelope the name of the company/firm, Expression of interest notice number, name of Expression of Interest, date of opening and details of document cost and earnest money deposited otherwise the Expression of Interest will not be opened and strictly returned to the party.

Centre of excellence for vegetables is situated at Chandi in Nalanda District of Bihar. It is executed in 18 acre of land.
