Tender Enquiry for supply of Vegetable Seeds of Pea, Hybrid Tomato, Capsicum (Shimla Mirch), Seedless Cucumber, Bottlegourd, Cucumber, Spongegourd, Ridgegourd, Pumpkin and Spices seeds of Chillies, Azwain, Methi, Saunf in 2014-15 in the State of Bihar.

For timely and smooth execution of different schemes of horticulture development in 2014-15 in the state of Bihar, Bihar Horticulture Development Society (BHDS), Patna, Bihar invites Tender for supply of vegetable **Seeds of Pea, Hybrid Tomato, Capsicum (Shimla Mirch), Seedless Cucumber, Bottlegourd, Cucumber, Spongegourd, Ridgegourd, Pumpkin and Spices seeds of Chillies, Azwain, Methi, Saunf** from Govt., Semi Govt. Organisations & Registered Seed Producers which have its own production centre as well as having facilities of fundamental infrastructure.

Tender forms including terms and conditions, specifications, quality and quantity can be obtained from the State Horticulture Mission, Patna on all working days (Monday to Friday) between 11.00 hours to 16.00 hours by payment of a demand draft of ₹1000.00 drawn in favour of Bihar Horticulture Development Society, Patna. It may also be downloaded from the website www.horticulture.bih.nic.in. In case of a downloaded form DD of ₹1000.00 has to be attached with the form.

Applications for Tender in envelope duly super-scribed "Application for supply of (name of component)" addressed to the Mission Director, Bihar Horticulture Development Society, Patna should be submitted in State Horticulture Mission, 2nd Floor, Pant Bhawan, Bailey Road, Patna.

The last date for submission of the completed Tender will be on or before 15.00 hrs. on 04.09.2014 and the Tender will be opened on the same day at 16.30 hrs in presence of the applicants or their authorized representatives who choose to attend.

Bihar Horticulture Development Society, Patna reserves the right to revise/change/cancel the EOI without assigning any reasons thereof.

Components for supply :

Vegetable Seeds :- Pea, Hybrid Tomato, Capsicum (Shimla Mirch) (Variety recommended for poly house cultivation), seedless cucumber (variety recommended for poly house cultivation), Bottlegourd, Cucumber, Spongegourd, Ridgegourd, Pumpkin in kits of 200gm packet.

Spices Seeds :- Chillies, Azwain, Methi and Saunf

General terms & conditions of Tender :-

1. Govt., Semi Govt. Organisations & Registered Seed Producers applying for Tender should have at least 1 year experience of supplying the concerned components as per their proposal. Photocopy of bills, Cash Memos, Delivery Notes, Supply Order issued from Govt. or Non Govt. Organisation should be attached with Tender documents in support of experience, which clearly indicates firm's name and volume supplied with componentwise pricelist.
2. Tender submitted without relevant papers/documents will be rejected.
3. The annual turnover of the firm must not be less than ₹50.00 lakhs for the last one year. Audited balance sheet along with annual report and I.T. return should be submitted as supporting documents.
4. The successful bidder should submit an annual registration fee of ₹10,000/- each for vegetable and spices seeds separately in the form of demand draft payable to **Mission Director, Bihar Horticulture Development Society, Patna**. The annual registration fee is non-refundable.
5. The firm should furnish a copy of sales tax registration, TIN and VAT number.
6. Telephone No./Mobile No./Email and Full Address of the applicant must be mentioned in Tender Documents.
7. The successful suppliers will have to enter into an agreement with the Bihar Horticulture Development Society covering, inter alias, the following points :
 - i. The seeds supplied must be certified/hybrid & free from all diseases and pests. In this regards certificate have to submit issued from recognised laboratory/SAU.
 - ii. The seeds shall have to be supplied at the premises of different districts of the state as per terms and conditions mentioned in agreement. No other charges such as Octroi, Packing, Forwarding, Freight, Insurance, Loading and Unloading, Clearance etc. will be allowed.
 - iii. The purchaser and the supplier shall make every effort to resolve amicably by direct negotiation. In case of any disagreement or dispute arising between them under or in connection with the supply, the matter shall be settled under the Court of Law within its jurisdiction at Patna.
 - iv. Suppliers will have the full responsibility per the final supply orders given by Assistant Director, Horticulture of concerned districts in this regards.
 - v. Performance security deposit if any, can be forfeited in case of non-performance of the contract and exceeding time limits indicated in the supply order.
 - vi. Names of quality seeds/available stock/variety and source of production field from where the seeds will be supplied should be clearly indicated and the society reserves the right to inspect these premises.
 - vii. The seeds should be as per the quality specifications mentioned in the Tender notice. Failure to supply as per the quality specifications shall result in for forfeiture of EMD, blacklisting and legal action against the suppliers.
 - viii. Failure to supply as per the time limit specified in the supply order shall result in 2% deduction in the rest of the quantity to be supplied for every day

delayed till the supply date. Further the supply order still pending after the deadline may be cancelled.

8. The BHDS is free to evolve strong punitive measure against erring companies & suppliers to safeguard the interests of farmers in order to ensure proper utilization of public funds.
9. Under the Two Bid System, the **Technical Bid** shall consist of all technical details along with commercial terms and conditions and, **Financial Bid** shall indicate unit price for components proposed for.
10. EMD and document costs will be the part of Technical Bids only.
11. **Earnest Money Deposit (EMD)** of Rs. 50,000/- (Fifty Thousand) should be furnished in the form of Demand Draft in favour of **BIHAR HORTICULTURE DEVELOPMENT SOCIETY** payable at any nationalised bank situated at **Patna (Bihar)** town. The earnest money of the technically unsuccessful bidders will be refunded after the rejection of their Tender and will be retained from the successful firms up to the time of execution of contract or till the submission of security deposit and signing of agreement.
12. The **Technical Bids** along with earnest money and the **Financial Bids** should be **sealed** and submitted by the applicant in separate envelopes duly superscribed as Technical Bid and Financial Bid, respectively and should be put in a bigger envelop superscribing Tender for supply of seeds of Pea, Shimla Mirch, Seedless Cucumber, Bottlegourd, Cucumber, Spongegourd, Ridgegourd, Pumpkin and Chillies (for Spices) and addressed to Mission Director, Bihar Horticulture Development Society, Patna.
13. All the **Bid** documents should be signed by the **authorized person, carrying the prescribed letter of authority** and his full name and status should be indicated below his signature with the seal of Govt., Semi Govt. Organisation & Registered Seed Producer etc. It is mandatory for bidder to indicate Sl. number on each page of Tender Documents. It is mandatory for the bidder to put serial number on each page of the tender document.
14. Rate proposed in financial bids must be inclusive of all taxes and freight for destination etc. at district headquarters (FOR district head quarters) Financial Bid will be quoted in figures as well as in words. In case of any ambiguity amount quoted in figure, then in words will be considered. The quotation of rate of component must be with respect to desired technical specification of that component mentioned in Tender paper. Bidders should must mention the capacity of supply per month with available stock & place of godown/store situated in the state.
15. Conditional Tender will not be accepted.
16. No claim will be entertained afterwards for any increase in market price or otherwise.
17. **The Technical Bids will be opened first** and will be evaluated by the tender evaluation committee at the society. Only such bid will be evaluated in which required Earnest Money and Tender document cost are deposited along with the Technical Bids and that meets other conditions of the Tender. Evaluation of the Technical Bids, shall be carried out by a committee constituted by the Society,

which shall look into compliance of specifications and of other conditions of Tender document. At the second stage, **Financial Bid of only technically acceptable and offers complying with Tender conditions will be opened**, for further evaluation.

18. Payment against Bill/Invoice shall be released only after satisfactory supply. No interest will be payable on the delayed payment. Payment will be made directly to the supplier through Demand Draft/Crossed A/c payee Cheque/RTGS. 90% payment will be made upon production of receipt of supply of seed, whose number/quantity will be indicated in the receipt. Ten percent (10%) payment will be made after harvesting of that crop for which seed have been supplied. If any complaint is received from farmer regarding quality of the seed from sowing to harvesting period of the crop then 10% amount will be seized and shall result in forfeiture of EMD, blacklisting and legal action against the firm.
19. The firm shall submit an affidavit from notary that "the firm has not been blacklisted by any State Govt./Union Govt." and no legal issues regarding seeds supply is pending in any court as well as the stock mentioned in the Tender is correct.
20. Mission Director, BHDS, Patna reserves the right to reject/cancel the registration of firm at any time if he/she is satisfied that it is desirable to do so in farmers interest after giving an opportunity of hearing such an applicant. The decision of Mission director, BHDS, Patna shall be final and binding.
21. **Proposals should be addressed to Mission Director, State Horticulture Mission, Directorate of Horticulture, Department of Agriculture, 2nd Floor, Pant Bhawan, Bailey road, Patna and must reach on or before the date & time mentioned in the tender notice.**
22. **Tender can be sent by post /courier/or by hand. In case of delivery in person, the document may be dropped in the proposal box kept for this purpose at the Mission Director's office at the address mentioned above.**
23. Bidders or their duly authorized representatives may be present at the time of opening the main envelope and the Technical bid, at the time and place indicated in the Tender document. Time and Place for opening of Financial Bid shall be immediately after evaluation and shall be communicated through a notice at the office of Mission Director.
24. **Tender received late after due date and time, will be rejected. The Bihar Horticulture Development Society will be in no case responsible for late delivery or non-delivery of Tender papers due to postal delay etc.**
25. Participation in the Tender will automatically imply the acceptance, on part of the participating Government agency of all the terms and conditions of this Tender.
26. Since the Tender has been invited for supply of seeds for above components as well as timely execution of the schemes, so the rate submitted by any firm found to be lowest in any components will be the rate per unit of supply for that component for the firm. In case the successful bidder is unable to supply the required quantities of seeds mentioned in the supply order; then negotiations can be carried out with other second and further placed firms for supply of material at

the rate of the first successful bidder. The rates quoted should not exceed NHM norms.

27. Seeds of Pea, Shimla Mirch, Seedless Cucumber, Bottlegourd, Cucumber, Spongegourd, Ridgegourd, Pumpkin, Chillies, Azwain, Methi and Saunf must be certified/ hybrid & free from all diseases & pests. Seeds of Tomato only be hybrid.
28. The seeds of bottlegourd, cucumber, spongegourd, ridgegourd & pumpkin must be certified/hybrid seeds and must be supplied in a kit of 200gm. in which 40gm each vegetable seed will be packed in polythene pouches.
29. The rate fixed for the above mentioned crops will be valid for one year from the finalisation of Tender date.

Technical Qualification for Bidder :-

ii.	Bidder's Office	:-	Should have office in Bihar. Store/Godown for storage seeds should also be available in the state of Bihar.
iii.	Bidder's Annual Turn Over	:-	Not less than 50.00 lakh during the last financial year. Furnish I.T. returns of concerned financial year with PAN card.
iv.	Experience	:-	Should have at least one years experience in the concerned field.
v.	Document' Cost	:-	Rs. 1000/- (One Thousand)
vi.	Earnest Money Deposit	:-	EMD will be Rs. 50,000/- (Fifty Thousands)
vii.	Registration Fee	:-	Registration fee will be Rs. 10,000/- each for vegetable & spices seeds separately will be non-refundable. It will be essential only for finally qualified bidder.
viii.	Certification	:-	Proof of evidence regarding seeds to be supplied is certified/hybrid and free from all diseases and pests have been issued from recognized laboratory/SAU.
ix.	Bidder's Sale Tax	:-	Furnish copy of sale tax with TIN/VAT number
x.	Affidavit	:-	From notary stating that the firm has not been blacklisted/ debarred by any state govt./Central Govt. on account of corrupt or fraudulent practices.
