Procurement of Carton Boxes with Multicolour Printing

Sealed bids are invited in two bid system for rate contracts for one year (extendable) from reputed\registered manufacturers/suppliers for manufacturing of carton boxes for fruits like Litchi/Mango with multicolour printing and supply in various locations in the various district of Bihar.

The State government of Bihar, Bihar Horticulture Development Society (BHDS), Patna (State Horticulture Mission) would like to use the multicolour carton boxes of various sizes for branding of Litchi fruits under One Year Litchi Mahotsav programme in the State. Bidder's may find two specification in the following table for packing and transportation of Litchi. Bihar Horticulture Development Society urgently requires 300000 nos. of carton boxes with multicolour printing for packing and branding of Litchi fruits.

The Contents for the design of printing shall be provided by BHDS to the selected bidder(s)

1. Bid price

- The contract shall be for the full quantity as described and quoted by the bidders.
- All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- Sales Tax/VAT and any other local taxes should be clearly mentioned separately in terms of percentage and amount in the price sheet.

- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) The prices shall be quoted in Indian Rupees only.
- g) Each bidder shall submit only one quotation.

2. Documents required to be submitted along with the bid

- a) Copy of the Income Tax return for last three years (2008-09, 2009-10, 2010-11).
- b) Copy of PAN card.
- c) Copy of the VAT Registration Certificate.
- d) Average annual turnover for the last three financial year should not be less than 50 lacs.
- e) Audited balance sheet along with annual report and IT return filed should be submitted for the last three years.
- f) The Bid should accompany a Demand Draft of Rs 20000/- drawn on any Nationalized Bank in the Name of **Bihar Horticulture Development Society** payable at Patna towards Earnest Money Deposit (EMD).
- g) Bidder shall submit an affidavit from Notary that" the company has not been blacklisted/ de-registered/ barred by the State Government or Union Government.

3. Validity of Quotation

Quotation shall remain valid for a period of not less than 90 days after the deadline date specified for submission.

4. Evaluation of Quotations

The purchaser shall evaluate and compare the quotations determined to be substantially responsive i.e. which

- a. are properly signed; and
- b. confirm to the terms and conditions and specifications.

5. Award of Contract

BHDS will finalize the rate contract of the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- b) The purchaser reserves the right at the time of award of contract or in between execution of the programme (s) depending on the need to increase or decrease the quantities of items indicated without any change in the unit price or any other terms and conditions.

6. Delivery Period : Within 20-25 days from the date of award of contract

7. Penalty

- a) For delayed delivery- 1/2 % of the value of the contract per week or part thereof after expiry of the delivery period subject to maximum 10%.
- b) Failure of the award - EMD will be forfeited.
- c) Variation in specification - material will be rejected and cost of the said material will be recovered from the supplier.
- d) The supplier shall replace defective material any items found to be of Sub Standard quality, immediately.

8. Payment: 90% payment shall be made immediately after completion of work and submission of documents. 10% payment shall be made after the completion of contract period.

9. Submission of Bid:

The last date for submission of the completed bid is 10th April 2012 up to 3.00 pm.

10. Tender Opening

The bid will be opened on 10th April 2012 at 3.30 hrs in presence of the bidders or their authorized representatives who ever choose to attend.

11. In the event of the date specified for bid receipt and opening being declared as a holiday for BHDS, the due date for submission of Bids and opening of Bids will be the following working day at the appointed times.
